

ALLOWABLE PURCHASES

The list of allowable purchases is not all-inclusive. It is a list of common goods and services. If something is not listed, please contact your trust officer for additional information. The list of restricted purchases is short but is based on the guidelines outlined in Social Security POMS.

Please note the following general guidelines (these guidelines are further described in the disbursement manual and your trust officer will assist you in ensuring that all allowable purchases are made with ease):

- Funds must be for the sole benefit of the beneficiary. Funds must be distributed to a third party; they cannot be given to the trust beneficiary.
- Cash cannot be paid to the trust beneficiary because cash will count as income under the eligibility rules for most public benefit programs. This can be avoided by simply paying vendors and service providers directly from their invoice.

• Receipts must be provided to back up all purchases made using the funds in the trust.
